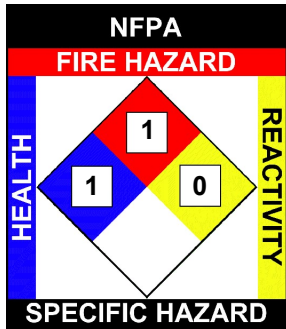

### 3 COMPOSITION/INFORMATION OF INGREDIENTS
